General

What is the club's history?

CFCA was founded in 1973 and celebrated its 30th anniversary in 2003 in conjunction with the 50th anniversary of the Corvette. CFCA has been a member of the National Council of Corvette Clubs (NCCC) since 1973 and is currently the largest NCCC-sanctioned club in the Florida Region. Members may learn from others who have "been there, done that" with their Corvettes and discover how to best maintain, care for, and improve their vehicles. CFCA offers a host of activities you may participate in as well as NCCC's sanctioned competition program to earn NCCC points towards awards. But we are first and foremost a social organization geared towards enjoying each other's company and having FUN with our very special cars.

Who can join CFCA?

Membership is open to any Corvette owner and spouse (or significant-other, provided they reside at the same address). Child Dependent (ages 16-21) and Associate memberships are available, too.

How is the club organized?

CFCA is registered as a not-for-profit corporation in the state of Florida and is governed by an elected Board of Directors.

What positions comprise the Board of Directors?

The club's Board members include the elected positions of President, Governor/1st Vice President, Membership Director/2nd Vice President, Secretary, and Competition Director, plus the board-appointed positions of Treasurer, Public Relations/Marketing Director and Webmaster. Non-voting board-appointed positions may include Assistant Membership Director, Assistant Webmaster, Newsletter Editor, NCM Ambassador, Charity, Warm-n-Fuzzy, Sergeant at Arms, and others as needed.

How do I contact a club Board Member?

CFCA Board Members may be contacted by email using our “perpetual” email addresses such as president@cfca.net, governor@cfca.net, etc. Use board@cfca.net to send email to every Board Member. Full contact information is available in the CFCA Membership Roster published in the Members Only section of the CFCA website. Contact webmaster@cfca.net if you need the Members Only username & password.

Other than a Board position, how else can I actively participate?

CFCA members may volunteer to participate on special committees for selected annual events (Christmas Party, Anniversary Party, Florida Keys trip) and special functions (Charity, Public Relations, Parades, Nominations, etc). We encourage ALL members to suggest new events and to take an active role by chairing or helping to coordinate events.

Where can I get more information?

The club’s By-Laws and Standard Operating Procedures (SOP) provide additional details and are available to all club members in the Members-Only section of the club’s website. Both documents are reviewed annually by the CFCA Board of Directors with changes submitted to the membership for approval at our Annual Meeting in March of each year.

Meetings

How often does the club meet?

We understand that our members have busy personal and business schedules. In order to encourage participation and allow ample opportunity for our members to attend as often as possible, regular meetings are usually held twice monthly on the first and third Thursday at 7:00 P.M. The only exception to this is that we usually only hold one meeting per month during the hot summers of July and August.

We hope you can attend both meetings but if you can only make one, that's fine, too! Quarterly social dinner meetings are held in other locations around town to accommodate members who live a considerable distance from the standard meeting location.

Where does the club meet?

The current meeting place is Carl Black Chevrolet, 11500 East Colonial Drive, Orlando, FL 32817. The meetings are held in the lobby of the Buick building just east of the main GMC/Chevy building. Check the [CFCA Calendar of Events](#) on the club's website for the latest info.

What is the format of the meeting?

Meetings are run by the club President and are convened, conducted and adjourned in a semi-formal atmosphere and in a manner similar to Roberts Rules of Order, reasonably enforced by the Sergeant at Arms. Meetings generally last no more than one hour. Each Board member provides a report to the membership, followed by a review of old business and opening the floor to new agenda items. Following the meeting, members often adjourn to a local restaurant for food and more Corvette conversation. Some meetings may also host a guest speaker, technical session, or vendor presentation. We try our best to get a LOT of information out in short order!

Where can I get more information?

If you can’t find what you are looking for in our expansive website, just ask any CFCA Member or Board Member. We’ll be happy to help.

Membership

What is a REGULAR Member?

A Regular member is one who is a Corvette owner, is eligible to hold a Board position, and has full voting rights. Regular membership can continue for up to 12 months after disposing of, or sustaining loss of their Corvette. Beyond the 12-month grace period, members can continue CFCA membership as Associate members.

What is an ASSOCIATE Member?

An Associate is a former CFCA member who does not currently own a Corvette. An Associate member cannot hold a Board position, nor vote in club elections.

What is an HONORARY Member?

An Honorary member is one who is elected by the general membership as a special recognition. Honorary members pay no dues, have no vote, and cannot hold office. Honorary membership is for a 12-month period.

What is a DUAL Member?

A Dual member is a CFCA member who is primarily a member of another NCCC club. Dual members may vote but cannot hold office.

What is a DEPENDENT Member?

A Dependent member is a child dependent, between the ages of 16 and 21, of a dues-paying member. Dependent members have no vote and cannot hold office.

I've heard the term "Carryover." What is it?

Carryover is a term generally used by our Membership Director to identify new members who have joined CFCA/NCCC near the end of the calendar year (after September 1st). Such members are allowed to be "carried over" to the new year without the need to pay an additional membership fee.

What is a Primary Member?

Per NCCC, a Primary member is the owner of the Corvette.

What is a Secondary Member?

Per NCCC, the Secondary member is the spouse or significant-other of the Primary member.

Please explain my member number?

Each CFCA member is assigned a member number by NCCC in the form FL186-9999. "FL" designates a club in the Florida Region. CFCA is club number 186. The next 4 digits identify the individual member, sequentially assigned since the club's inception. Where an "L" suffix appears, the member is female. The suffix is used by NCCC in sanctioned competitive events (such as autocross, where there are both men's and ladies' classes.)

Where does my money go?

When you become a member of CFCA, you also become a member of NCCC. The majority of the CFCA membership dues is allocated to NCCC membership. Any remaining portion helps offsets the cost of your CFCA shirt, badge, awards, website, charitable support, etc.

How do I find contact information for another member?

A club roster is updated and published regularly and is available to all members in the Members-Only section of the [CFCA website](#). We consider our roster to be confidential, so please don't share roster information with non-members!

Can I be a member of another Corvette club or organization?

Yes, of course! But please keep in mind that certain information is provided for exclusive use of our membership, the password(s) to our Members-Only section of the website, our club roster, email list, etc. These items are confidential to CFCA and should not be shared outside the club. CFCA policy dictates that personal member information (such as our membership roster) may not be sold or otherwise distributed to third parties.

Dual Members (CFCA Members who are also members of another NCCC club) need not pay the NCCC membership fee twice.

I've sold my Corvette and/or purchased a new one. Who do I notify?

Please notify the CFCA Membership Director (Email: membership@cfca.net) with the details. NCCC also needs to be advised of this change!

Events & Competition

What types of events are held?

Many of our events include social activities, road trips, display car shows, parades, fund raisers, caravans, concours car shows, drag racing, rallyes, and funkhanas.

Can any member suggest an event?

Yes! Suggestions and new ideas are always welcome. Simply contact our Competition Director or any Board member.

Can any member host an event?

Yes! In fact, we encourage it! CFCA's Board of Directors is in place to guide our events and ensure that we operate in a safe manner according to published regulations and standards. It's with the active participation of our members that the club continues to grow!

What is an event Chairperson?

The Chairperson is the person who "runs" an event, coordinating with the Board on items such as date, time, place, budget, promotion, etc. The Chairperson is the focal point for event information and is responsible for getting the Liability Waiver form signed by all participants. Any member may chair an event with Board approval. When necessary, events may have multiple Chairpersons or Assistant Coordinators. For additional details, please refer to CFCA's Standard Operating Procedures document.

What is a "NCCC Event"?

Events of this type are sanctioned competition events and qualify the participant for NCCC points (regional and nationwide). Such events include high and low speed autocross, rallyes, and concours. For additional information on the sanctioned competition program or to obtain a copy of the rule book, contact the NCCC at 800-245-VETT (8388).

What is a "NCM Event"?

Events of this type are published events hosted by the National Corvette Museum. Please refer to the NCM website at www.corvettemuseum.com for event details. CFCA is a proud Business Member of the National Corvette Museum and we encourage all CFCA members to join the NCM and support their efforts at enhancing the Corvette hobby.

What is a "Club Event"?

A CFCA "Club Event" is one that we have created or one that we, as a group, choose to support and thereby recognize our members that participate. At our regular meetings, as new events are identified, we may choose to make an event a "Club Event" generally if 3 or more CFCA members indicate interest in participating. We then establish who will be in charge of organizing CFCA's participation by assigning an event Chairperson. Club events will be published in our events calendar on the CFCA website. Other Corvette-related events may appear on our calendar during the year that are not "Club Events" but are provided for information only. Only approved Club Events with signed liability waivers are covered by our NCCC Insurance.

What's all this stuff I've heard about "points"?

CFCA encourages all members to participate in as many events during the year as possible and to become involved in directly supporting those events. Member participation is accounted for simply by signing the NCCC Liability Waiver form at all meetings and events. At the conclusion of each year, the top 10% of our members, as evidenced by their participation in club events, receive an award at our annual Christmas party. The CFCA Competition Director maintains an accounting of participation and attendance and communicates this information to the Board as a means to gauge the success of a particular event. For additional details, please refer to CFCA's Standard Operating Procedures document under the headings "Member Participation and Contributions" and "Awards".

What's a CONCOURS?

A concours is a show or contest of vehicles and accessories in which the entries are judged chiefly on excellence of appearance and turnout. [Source: NCCC Sanctioned Competition Program]. Cleanliness is paramount in a Concours d'Elegance show.

What's an AUTOCROSS?

An autocross is a gymkhana, speedkhana, slalom, or parking lot speed event, where a course is set up using pylons and/or track. Cars can race against the clock, not wheel-to-wheel. It is designed to test driver skills. The course is less than one mile in length.

What's a RALLYE?

A rallye (or "rally") is like the directions one gives to a friend for getting to a new house in the suburbs. It's more than a test of one's ability to follow directions; more than intense observation. It's doing many things at once including the adherence to a time-table speed. There are many types of rallyes, such as Time-Speed-Distance, Gimmick (answering questions to determine directions), and Chance (fun rallyes, simple courses, Poker rallyes, Hare & Hound rallyes).

Why do I have to sign a Liability Waiver?

Via our association with NCCC, our published events are covered by NCCC's liability insurance program. Each participating member or guest is required to sign the waiver at each event to comply with the requirements of this program. This form is also used by CFCA to account for member participation during the year.

The club's By-Laws and Standard Operating Procedures provide additional details and are viewable by all club members. Fundraisers

What does CFCA do to raise money?

Through the efforts of the CFCA Public Relations and Marketing Director and support of the general membership, CFCA solicits sponsors to advertise on the CFCA website in exchange for a donation to the club to help further our activities as well as charitable donation efforts. All CFCA members are encouraged to reach out to area businesses and vendors to encourage them to become CFCA sponsors under the guidance of the. The CFCA webmaster will post appropriate banner advertising on the club website as requested by the CFCA Public Relations and Marketing Director.

On occasion, CFCA may also participate in various events throughout the year, such as parades, fundraisers, charity car shows, etc., to earn money for select charities.

Why do we do Parades?

Parades in which CFCA is offered payment as a donation for our participation is another source of revenue for CFCA in support of our members and our favorite local charity, [The Russell Home for Atypical Children](#).

Parades generally consist of transporting community dignitaries in your Corvette, often in conjunction with a federal holiday such as Christmas, Memorial Day, Independence Day, etc. Though our requirement is generally for convertibles, we often use coupes as well. For convertibles, the participants may sit atop the rear deck only with the Corvette owner's permission. The decision to place one or two participants atop the car is at the car owner's/driver's discretion.

What do I need to do to prepare for Parades?

Items to bring include a rug or blanket for the participants to sit on (to protect your paint), a few towels to step on (to protect your seats), a roll of masking tape (to affix signs to your doors), and a few cleaning supplies such as spray detailer (for last minute "touch-ups"). For holiday parades (such as Christmas, St. Patrick's Day, etc.) we often decorate our cars. American Flags have become popular among our members since the tragic events of September 11th.

Where can I get more information?

Contact the event chairperson or any Board member for information on specific events.

Charity

What are the club's charities?

CFCA is a strong supporter of [The Russell Home for Atypical Children](#), right here in Orlando. Over the years, CFCA and its members have donated a considerable amount to the Russell Home through fundraisers such as our Homecoming events and charitable car shows. In addition to the club's cash donations, our members continually support the home with gifts, clothing, cleaning supplies, and periodic work parties.

All CFCA members are encouraged to visit the Russell Home at least once each year during one of our drive outs so that you can experience first hand why we have chosen this loving and worthwhile organization as our primary charity.

Why is CFCA's charity different from NCCC's?

NCCC's chosen charity on a national level is the St Jude Children's Research Hospital which CFCA supports via our association with NCCC. A number of years ago, CFCA elected to focus our charitable efforts directly towards our local community.

Where can I get more information?

The CFCA Charity Committee Chairperson is appointed each year by the Board and is our primary point-of-contact for all club-related charity functions. If you have an idea for a great charitable fundraiser or some other activity, please let the Chairperson know!

Associations

What is the National Council of Corvette Clubs?

NCCC was founded as an all volunteer, non-profit organization in 1959 by a small group of Corvette enthusiasts and is the largest Corvette organization in the United States. Today there are more than 280 clubs in 15 regions with more than 15,000 members.

What does NCCC membership mean to me?

The purpose of NCCC was (and still is) to promote interest in Corvette ownership and operation, to publish information on the use and operation of the Corvette and to establish an organized effort to encourage others to participate in the enjoyment connected with the use of the Corvette! The largest single benefit is the insurance program which provides liability coverage to all members participating in published events. Other NCCC member benefits include Blue Bars magazine, Future Corvette Owners Association (to instill interest in the Corvette hobby with the younger generation), the sanctioned competition program, National Conventions, etc. For more information on the National Council of Corvette Clubs, visit the NCCC website at www.corvettesnccc.org.

How is CFCA affiliated with the National Corvette Museum?

CFCA and many of its members are active supporters of the NCM, dedicated to preserving the legacy of the Corvette. In December of 2001, CFCA became a Business/Club Member of the NCM. CFCA encourages its members to also become NCM supporters – in fact, CFCA members can become NCM regular or family members at a 25% discount thanks to our business membership status! Communication

How does the club communicate with its members?

Information is provided to members via our award-winning website (<https://www.cfca.net/>) as well as a private Members Only club email list. All CFCA Members are automatically subscribed the club email list upon joining CFCA. Any email sent to the list at cfca_orlando@googlegroups.com (or cfca@cfca.net as a shortcut) is automatically forwarded to all CFCA members.

Does the club require Email?

Email is not a requirement, although most CFCA members do have internet access and email capability. We believe Email and website access allow for more immediate communication of club events and other pertinent or time-sensitive information. We encourage all members to visit our website often.

What about Social Media?

CFCA's Group Page is on Facebook at <https://www.facebook.com/groups/CFCAGroup>. Go check it out!

Why doesn't CFCA have a newsletter?

We have transitioned to focus more on the website and email list to communicate with the membership, rather than a hard copy newsletter. We have found that publishing and

mailing a hard copy newsletter is extremely expensive and by using alternate, electronic means of communication, we are able to conserve funds which we can use to otherwise support our membership and charity.

I've changed my Email address. Who do I notify?

At a minimum, you should notify the Membership Director, so that the club records can be kept current. Simply send an Email to membership@cfca.net, with both your OLD and NEW Email addresses.

Who can send Email to the club mailing list?

Only current CFCA members may post messages to the club mailing list by simply sending email to cfca_orlando@googlegroups.com (or cfca@cfca.net as a shortcut) The CFCA email list is considered confidential so please do not share information from this list with non-club members. Contact webmaster@cfca.net if you need help accessing the mailing list.

How can I get a photo of MY Corvette on the CFCA website?

Just Email your digital photo (in .jpg or .jpeg format) to webmaster@cfca.net. Our website also has a section for personalized ("vanity") license plates of our members.

Where can I view photos from CFCA events?

There are tons of photos from older, past events on the CFCA website but in recent years we've gotten away from posting event photos on the CFCA website in favor of posting them to publicly accessible social media sites such as our Group page on Facebook at <https://www.facebook.com/groups/CFCAGroup>.
